WHEREAS, it appears to the Government of Kerala that the land specified in the Schedule below is needed or likely to be needed for a public purpose, to wit for the land acquisition of 4.549 Hectares of land in Kulathummal, Ottasekharamangalam, Kezharoor & Vellarada villages of Tvpm District for the development of Karamana - Vellarada road reach 3.



AND WHEREAS, in exercise of the powers conferred in sub-section (1) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), Government of Kerala have decided to conduct a Social Impact Assessment in the area specified in the schedule below.

NOW THEREFORE, sanction is hereby accorded to Social Impact Assessment Unit, viz. Kerala Voluntary Health Services Mullankuzhi, Collectorate P.O., Kottayam to conduct a Social Impact assessment Study and to prepare a Social Impact Assessment Plan as provided in the Act. The process shall be completed within a period of two months in any case.
